## **KEY ACCOUNTABILITIES**

- Operate plant or machinery to achieve predetermined tolerances or standards and responsible for completion of activities to a quality specification.
- Work under minimal supervision and determine the most appropriate means of performing given activities from within a range of established methods.
- Deal with routine problems that arise within their sphere of work without support through the application of acquired knowledge and reference to standard guidelines and manuals. Resolve complex problems with the assistance of others.
- Actively participates in team meetings and pro-actively offers suggestions for improvement drawn from own knowledge and experience.
- Provide guidance and on the job training to other team members.
- Report hazards and participate in consultation process on work health and safety matters. Select and apply safe working procedures. Participate in risk management activities. Ensure other staff understand risks involved and work in accordance with safe working procedures. Ensure first aid and emergency procedures are in place and followed.
- Identify and report environmental hazards, rectify simple hazards. Demonstrate knowledge of Roads and Maritime Services commitment to improving environmental performance.
- Understand and apply correct procedures in relation to disposal of waste materials and

equipment.

 Perform measurements to confirm quality both during and on completion of the work and compare the results to engineering plans or specifications. Complete related paperwork correctly. Follow established quality procedures.
