#### Primary purpose of the role

- Oversee customer service surveys, audits and on-site inspections to ensure work is being executed in accordance with agreed standards and agreements, and plan for improvements.
- Undertake analysis on contract statistics and performance, research and collate information for reporting, monitoring and evaluation purposes and implement plans that will contribute to ensure agreed outcomes are achieved.
- Manage compilation, coordination and monitoring of budgets for facilities management work and provide regular reports to Senior Management.
- Assist the Manager, Building Services with undertaking WH&S and Risk Management audit reviews and monitoring.
- Coordinate the improvement and implementation of operational procedures and processes for the Asset and Facilities Management working stream.
- Work closely with the team to complete tasks and implement plans to ensure agreed outcomes are achieved.

## Key challenges

- Coordinating numerous internal and external stakeholders, with the expectation of delivering outstanding customer service from the Facilities Management team, Help Desk and external service provider.
- Providing accurate data and service level reviews for the Senior Manager, Building Services and Facilities Management team; and driving continuous improvements in the asset and facilities management service areas.
- Performing a range of activities, given competing demands and priorities, and the need to adapt and assimilate information quickly to ensure outcomes are achieved and driving continuous improvements in the facilities management service area
