Agency overview

The Planning, Industry and Environment Cluster was formed in 2019. The Cluster drives greater levels of integration and efficiency across key areas such as long-term planning, precincts, housing, property, infrastructure priorities, open space, the environment, our natural resources – land, water, mining – energy, and growing our industries. There is a strong emphasis on regional NSW.

The Housing and Property Group within Department of Planning, Industry and Environment (DPIE) oversees the management of state government assets, including the management of Crown land, the NSW Government's social housing portfolio, oversight of strategic use and disposal of government owned land and the management of the State's most notable tourist destinations, such as the Rocks, Sydney and the Sydney Olympic Park. The Group also includes the Aboriginal Housing Office, the Valuer General and the Land and Housing Corporation.

The Group leverages public and private sector expertise to improve place-based outcomes, providing greater access and choice of housing through initiatives such as an end-to-end housing strategy, and improving outcomes for Aboriginal communities to maximise community benefit from government owned land and property.

Primary purpose of the role

The Executive Director Metro will lead a new and innovative strategic and commercial portfolio aligned to the State Strategic Plan. This position drives the delivery of effective land management strategies and programs for the management and use of Crown Lands, providing innovation and support to communities. Investment in the retention and rejuvenation of green space in communities and public spaces across greater Sydney will be a key focus for this role along with strategic stakeholder management and coordination with broader planning priorities.



Lead and manage Crown Lands metro operations to ensure the effective delivery of Crown Lands strategic objectives, priorities and programs. The primary focus is on strategic planning and delivering of crown lans priorities across Greater Sydney. The role also provides expert and independent advice to the Deputy Secretary Crown Lands, Crown Lands Commissioner, Group Deputy Secretary Housing and Property Group, Secretary, and Minister/s.

The function also includes commercial operations to optimise outcomes and deliver projects for communities. This includes risk management and delivery of complex land management and property programs to ensure coordination with DPIE and other government agencies including the Department of Premier and Cabinet, and NSW Treasury.

Key accountabilities

- Oversee and lead the development and implementation of a Greater Sydney Crown Lands Strategy aligned to the State Strategic Plan and the Crown Lands Management Act 2019.
- Lead the design and delivery of the Commercial Strategy for Crown Lands, optimising effectiveness and efficiency in leasing, land tenure and commercial opportunities across the entire Crown Lands estate.
- Lead the implementation of the Crown Lands Green Grid portfolio strategy, coordinating senior executive engagement across DPIE, and with CEO's and Board's of peak industries and local government organisations.
- Design and implement projects for greater Sydney addressing diverse and complex planning and management priorities together with balancing community and stakeholder's interest.

- Provide expert strategic advice to the Deputy Secretary Crown Lands, Crown Lands Commissioner, Group Deputy Secretary Housing and Property Group, Secretary, and Minister/s on strategies to make the best use of existing and surplus land, infrastructure projects, and effective management of specific issues.
- Drive operational and organisational change initiatives aligned to strategic priorities including supporting
 the State Strategic Plan and managing and mediating complex stakeholder interests and needs within the
 directorate to develop a customer focused service delivery culture which is responsive to changing
 business, customer, and stakeholder needs.
- Maintain effective relationships with Ministerial Offices and at senior level and other government agencies
 on metro issues to foster and facilitate their optimal collaboration, participation and commitment to the
 NSW Government's priorities and strategy.
- Lead and guide, as a member of the executive team organisational change including ongoing professional development of staff and effective communication and engagement to ensure that regional services has the capabilities to deliver on its responsibilities and achieve desired outcomes now and into the future.

Key challenges

- Balancing competing environmental, natural resource and economic demands in the delivery of multiple strategies, given the large commercial, environmental and social value of land and marine assets in Greater Sydney, and long-term economic benefit to NSW.
- Providing innovative, conceptual solutions to issues requiring sound judgement within a politically and socially sensitive environment, developing policies and strategies which meet government and stakeholder needs.

The Executive Director has a high level of autonomy in making decisions on projects and transactions and, subject to delegations, recommending actions to the Deputy Secretary and Group Deputy Secretary of the broader group. The Executive Director is accountable for all elements of the successful delivery of projects and transactions within their portfolio subject to delegations under the *Crownlands Management Act 2016 and relevant policies and guidelines*.

Consultation with the Deputy Secretary Crown Lands is required on those decisions that involve a significant change to government policy, changes in the organisational structure of the branch, or where a higher delegation or approval is required.
