### Agency overview

We ensure young children get the best start in life by supporting and regulating the early childhood education and care sector. We are the largest provider of public education in Australia with responsibility for delivering high-quality public education to two-thirds of the NSW student population.

### Primary purpose of the role

The role leads and develops the operational strategy for the delivery of business services driving customer satisfaction, efficiency, quality, cost benefits and competitive advantage. This role develops the tactical plans and initiatives for the efficient and effective delivery of Business Services and Enablement across the Department in line with the agreed service catalogue and KPI. The role provides strategic and operational advice to improve performance.

### Key accountabilities

- Lead the strategic operation of all Business Services delivered to the Department by the Shared Services function and the ongoing improvement and advancement of the Shared Services service delivery model
- Collaborate across Shared Services functions to maintain an end to end view of the customer and of services, and identify and implement strategies to improve the customer experience
- Oversee and management of end-to end services including Tier 0, Tier 1 and Tier 2 level support for Business Services
- Manage and maintain data on service volumes, quality and performance and support cost to service and benchmarking priorities

- Lead strategic and business planning processes, aligning division priorities and resources to support division and Department shared objectives
- Implement strategic plans and optimise operational performance with appropriate controls and processes across the division to ensure the Department's commitment to school improvement and other critical priorities to reflect Government, Cluster and Department frameworks, policies and guidelines
- Drive and evaluate operational performance outcomes which contribute to the achievement of the division's strategy and be accountable for providing detailed and reliable analysis to support strategic and dynamic decision making processes and to identify and drive opportunities for innovation
- Foster a culture which drives and encourages high performance, collaboration, agility and accountability in the delivery of educational outcomes aligned with the division's and Department's strategy; while modelling and promoting a strong risk culture throughout the business unit in line with the department's risk management and governance frameworks.
- Lead, motivate and mentor the team, monitoring performance, fostering ongoing professional development and ensure staff have the knowledge and skills to achieve their work objectives in alignment with Department values.

## Key challenges

- Driving continuous improvement in Tier 0, Tier 1 and Tier 2 support services, supporting the business enablement of contemporary services through service redesign and educating the organisation on service frameworks, governance including SLA's
- Identifying new and innovative approaches and tools and embedding these in the culture and behaviours of the division to encourage collaboration, agile decision making and accountability. This include a focus on intelligence automation, intelligent analytics and behavioral strategies.
- Anticipating and responding to challenges which may impede effective delivery against strategic objectives, including identifying mechanisms to mitigate risks.
