

## Pre-Employment Health Declaration

Employment with the NSW Department of Education (the Department) is conditional on the applicant being suitable for employment and fully able to perform the inherent requirements for the position.

When completing the health declaration you as an applicant for employment must do so in the full knowledge of the position as outlined in the relevant role statement and/or selection criteria.

The primary purpose of this pre-employment health declaration is to assist the Department to ensure that no person is placed in an environment or given tasks that will result in physical or mental harm. It is not the intention of the pre-employment health declaration to deny a person employment solely because of disability, illness or injury. The health declaration is required so that the Department may take the appropriate and reasonable action to ensure the employee's health, safety and wellbeing.

You are required to disclose to the Department any pre-existing illness, disease, injury, aliment or condition that you have suffered or continue to suffer of which you are aware and could reasonably be expected to foresee, and could be affected by the nature of the proposed employment.

## **Privacy**

The Department takes your privacy seriously. All details provided on this form are treated confidentially. The completed health declaration form will be retained on your personnel file, which is kept secure at all times. Where employment is not taken up, for whatever reason, all documents relating to your application will be retained for six months and then destroyed.

The Department and its employees may use the information in your health declaration for the purpose of assessing your suitability for employment as a teacher, school administrative and support staff member or public servant. Further the Department may disclose that information to its legal advisers for the purpose of obtaining legal advice concerning your health declaration, and any legal proceedings in which your health declaration is relevant.

Should any circumstances change that may affect your capacity to perform the inherent requirements of the position that you are undertaking, you are obliged to inform your respective principal or manager.
