Agency overview

The Planning, Industry and Environment Cluster (DPIE) was formed in 2019. The Cluster drives greater levels of integration and efficiency across key areas such as long-term planning, precincts, housing, property, infrastructure priorities, open space, the environment, our natural resources – land, water, mining – energy, and growing our industries. There is a strong emphasis on regional NSW.

Housing and Property (HAP), a group within DPIE, oversees the management of state government assets, including the management of Crown land, the NSW Government's social housing portfolio and the oversight and strategic use and disposal of government owned land. The Group includes the Aboriginal Housing Office, the Valuer General and the Land and Housing Corporation.

HAP leverages public and private sector expertise to improve place-based outcomes, providing greater access and choice of housing through initiatives such as development of an end-to-end housing strategy for Government implementation, and improving outcomes for Aboriginal communities to maximise community benefit from government owned land and property.

Primary purpose of the role

The Executive Director of Commercial Development leads a team responsible for the design and delivery of new owned and leased office accommodation projects across the NSW, realizing the objectives of the Government Accommodation Policy and Government Accommodation Strategy. The Executive Director provides leadership, expert strategic advice and facilitates executive decision making to significant commercial property projects across the State within Property & Development NSW (PDNSW), as projects typically involve multiple agencies. The Executive Director will be required to establish and manage integrated cross-government project working groups and teams.



Key accountabilities

- Lead a team of property professionals and technical experts, including external consultants, responsible for delivery of large commercial property projects including development of owned projects and execution of lease pre-commitments.
- Lead and deliver accommodation planning and the delivery of government office accommodation that is
 cost effective, enhances the operational and environmental performance of the asset, supports flexible
 accommodation that addresses government and operational change, aligns with cluster/agency
 accommodation requirements and facilitate achievement of the Government's employer of choice goal
 to achieve and exceed employment benchmarks targeting disability, indigenous and cultural groups.
- Lead the establishment and management of cross-government integrated project working groups and teams required to align multiple agency interests to realise the objectives set in the Government's Accommodation Strategy.
- Lead the development of tailored funding strategies for developments including the delivery of business cases to secure Government investment in these projects.
- Lead the procurement and delivery of commercial developments across the State via agreement for lease, project delivery agreements, or direct construction partnering with leading industry experts.
- Lead effective strategic, tactical and risk management of property projects through effective due
 diligence and ongoing project management, ensuring informed decision-making accounting for factors
 including value, time, market, opportunity and risk, government policy and environmental and
 community impact.
- Lead stakeholder engagement with groups including ministerial offices, government agencies, councils, lobby groups and the community to ensure project objectives are realised.
- Provide expert advice to Ministers, Cabinet, DPIE / HAP Executive and government committees as required for property projects through high quality submissions and advice to the Deputy Secretary.

Key challenges

- Provide expert advice to achieve stakeholder support within the PDNSW leadership team and senior
 external stakeholders to ensure State and regionally significant office accommodation projects are
 delivered within time, cost and quality parameters as set out in the Government Accommodation Policy
 and reset from time-to-time in the Government Accommodation Strategy.
- Ensure high quality governance and ethical management of government property dealings that are highly visible, often controversial and subject to intense scrutiny by the media, stakeholders and regulatory bodies.
- Anticipate, identify and either effectively mitigate or resolve project and transaction risks or issues that may be technical, counterparty, political, policy, financial or legal related.
