Agency overview

Legal Aid NSW is the largest legal aid agency in Australia, comprising a Central Sydney office and 21 regional offices in metropolitan and regional centres across NSW and a number of specialist services and advice clinics. It was established under the Legal Aid Commission Act 1979 as an independent authority to assist economically and socially disadvantaged people to understand and protect their rights in the legal system. People with disabilities, from people from culturally and linguistically diverse backgrounds, women and children, Indigenous people and people with mental illness are some of the groups who may experience difficulties when enforcing and defending their rights.

Working in partnership with private lawyers, Legal Aid NSW provides legal advice, information and minor assistance and legal representation to eligible people in many areas of law. Legal Aid NSW also provides alternative dispute resolution services, community legal education programs, and publications on legal issues.

Primary purpose of the role

Process, assess, determine and administer applications/extensions for grants of aid within policy, guidelines and delegations to meet client service and Legal Aid NSW standards and benchmarks.

Key accountabilities

- Determine and administer applications for grants of legal aid.
- Ensure consistency in the application of Legal Aid NSW policies, guidelines, delegations and budgetary restrictions.
- Advise clients and/or their legal representatives in a timely manner as to the status and determination of applications.
- Provide information on policies, practices and processes.



- Maintain and create accurate records, reasons for determinations using the Grants management system.
- Contribute to the improvement in policies, guidelines and practices for Grants in order to enhance services to client, practitioners and other stakeholders.

Key challenges

- Achieving consistent and high level of performance in the processing, data entry and determination of applications and in client service.
- Determining applications within strict timeframes in a high volume environment.
