POSITION CONTEXT

Primary purpose of this position

Truck Drivers (MR Gang Truck) are required to competently operate Light and Medium Rigid vehicles (with a GVM of greater than 4.5 tonnes) and to hold a MR Class Licence. This position will also be expected to tow any trailers that their vehicle is rated to tow and to operate a HIAB or similar truck mounted crane.

In addition to the position's primary duties the Truck Driver (MR Gang Truck) also performs any of the duties of a Road worker Grade 3, as and when required.

KEY ACCOUNTABILITIES

- Works under limited supervision and accepts responsibility for their own work whether it is carried out individually or in a team environment. Provide guidance to other team members.
- Ability to deal with routine problems that arise within their sphere of work without support through the application of acquired knowledge and reference to standard guidelines and manuals.
- Actively participates in team meetings and processes and pro-actively offers suggestions for improvement drawn from their knowledge and experience. Apply interpersonal skills to assist members of the public and other team members and to ensure that team processes proceed.
- Understands and follows safe working procedures, identifies and reports hazards, participates in consultation processes on health and safety matters, rectifies simple hazards at their worksites without direction and report them accordingly.
- Contribute to the safety of the team by actively participating in the implementation and operation of a mobile traffic control configuration, including communicating advanced warning instructions to other heavy vehicles and road users approaching the traffic control configuration. Ensure the on-going safe and efficient operation of any vehicle under your influence through regular maintenance and daily, thorough checks.

- Identifies reports and rectifies environmental hazards in the workplace. Participates in Environmental Risk Management activities.
- Understands quality requirements, achieves the basic quality standards and performs basic measurement to confirm quality both during and on completion of the work.
- Assists the Work Supervisor and Team Leader in the application of all quality, safety and environmental processes to ensure the relevant Roads and Maritime Services policies are met.
- Contributes to the efficient operation of the team through timely delivery and safe loading and securing materials.
