# Primary purpose of the role

Responsible for overseeing network installations or decommissions, in accordance with agreed standards, as well as monitoring and maintaining the organisations ICT network and performance. The role also evaluates new network hardware and software to assess their relevance, impact, cost and viability.

# **Key accountabilities**

- Perform network monitoring and analysis, performance tuning, troubleshooting and escalating issues, including proactive problem resolution and complex problem analysis as necessary, to maintain network performance to meet user demand
- Reduce operational risk and improve availability of the network by ensuring network access, monitoring, control, evaluation and documentation practices are maintained and adhered to agreed standards
- Develop, maintain and perform operational procedures and ensure operational tasks are performed reliably and consistently to reduce the risk of unplanned outages
- Manages Crit-Sit situations to assist with service restoration activities and the review of all network and firewall change requests
- Evaluate new network hardware and software solutions and monitor the market for emerging technology, services, methods and techniques
- Collect and analyse operational data (especially incident and change records) to identify emerging trends and log problem records to assist with problem resolution and increased network availability.

- Managing the provision of proactive and reactive support, ensuring strategic and tactical objectives are aligned
- Ensuring required controls are adhered without compromising responsiveness and availability
