# **POSITION CONTEXT**

# Primary purpose of this position

# **Plant Operator Grade 1**

Plant Operator Grade 1 is primarily a labouring position which undertakes a range of Road Worker Grade 3 duties to support the efficient construction and maintenance of road infrastructure within New South Wales. Plant Operator also occasionally operates plant items that assist in the performance of labouring activities.

The Road Worker Grade 3 duties include: maintenance of established pavements; construction of new or enhanced pavements; establishment and maintenance of roadside fixtures and signage; construction and maintenance of bridges; application of road marking materials; application of bituminous sealing materials; establishment and maintenance of traffic signals and driver aid devices

**Plant Operator Grade 2** is engaged in the operation of major plant items that are used in Civil Construction and Maintenance activities. Plant Operator Grade 2 must be able to operate plant to the competent standards and carry out any of the duties of a Road Worker Grade 3, including: maintenance of established pavements; construction of new or enhanced pavements; establishment and maintenance of roadside fixtures and signage; construction and maintenance of bridges; application of road marking materials; application of bituminous sealing materials; establishment and maintenance of traffic signals and driver aid devices.

Plant Operator Grade 3 will mainly be engaged on Road Maintenance and Construction activities and must be able to operate plant to the competent standards. They will also be

required to carry out any of the duties of a Road Worker Grade 3. Staff do not qualify for payment as a Plant Operator whilst they are learning to operate machinery. They can only be paid to this classification when fully qualified and appointed to a position.

A Plant Operator Grade 3 must be qualified to operate at least two different types of defined plant which require the operation of hydraulic operated attachments. It is only operation of the plant listed below in the Progression Criteria for a Plant Operator Grade 2 that is recognised for progression purposes.

The operation of 2 Plant Items is the minimum for appointment. Staff may also be required to learn and operate other Plant items; however, the number will be limited by the need to keep staff retrained and competent in accordance with Transport for NSW/ RMS' Safe Plant Operation Policy.

# **KEY ACCOUNTABILITIES**

- Work under limited supervision either in a team environment or working independently, perform a wide range of labouring and related tasks which have been acquired through experience or formal training.
- Operate major plant items.
- Undertake routine problems that arise during the course of work without support through application of acquired knowledge and reference to standard guidelines and manuals. Complex problems are identified and resolved with the assistance of others.
- Actively participate in team meetings and processes and pro-actively offer suggestions for improvement.
- Apply interpersonal skills to assist members of the public and other team members to ensure team processes proceed.
- Understand and demonstrate responsibility for determining the legal framework of WHS in the workplace, apply knowledge of WHS legislation, policies and procedures in the workplace; and maintaining knowledge of WHS legislation, industry and organisational requirements.

- Ability to identify and report safety hazards in the workplace. Rectify simple hazards without direction and report them accordingly. Participate in safety risk management activities, including ENSITE Meetings. Ability to understand and follow WHS guidelines and understand and comply with the site WHS management plan. Identify where standard hazard controls may not be appropriate and suggest appropriate modifications. Ability to understand and apply the correct procedures in relation to WHS legislation and policies and demonstrate

knowledge of Transport for NSW's commitment to improving environmental performance.

Ability to understand the quality requirements of the tasks to be performed and the reasons for those requirements. Perform basic measurements to confirm quality of work and complete relevant documentation correctly. Achieve basic quality standards and follow established quality procedures within the scope of training provided in the role.
